A. Grove Elementary Cafeteria Tables – Approval

The aging and worn out cafeteria tables at Grove Elementary are in need of replacement. With the purchase of new tables, the staff at Grove Elementary will implement strategies to teach and practice social skills while sharing lunch with friends. The new tables will support seating of different sized groups to encourage student conversation in a dining-like setting. Quotes were received from four vendors and School Specialty was selected as the preferred vendor with a very durable table that is easy for staff to maneuver and the lowest purchase cost (see attachment A).

The Administration recommends the purchase of new cafeteria tables for Grove Elementary from School Specialty at a total cost of \$32,346.85. The Food Service budget will pay \$30,000.00 and the balance will be paid from the Buildings and Grounds budget.

B. Pitsch Early Learning Center Playground Equipment – Approval

The current playground equipment at Pitsch Early Learning Center is designed for older students and much of the equipment is too large for our current 3-5 year olds. It is also not accessible to students with disabilities. The new playground equipment will allow accessibility for all students and will provide play equipment that is the appropriate size for early childhood students. We have received quotes from three vendors and Minnesota Wisconsin Playground was chosen as the preferred vendor with the best pricing on the playground equipment and installation that meets all of our needs (see attachment B).

The Administration recommends the purchase of new accessible playground equipment from Minnesota Wisconsin Playground for Pitsch Early Learning Center for a total cost of \$239,054.00. The 4-K budget will pay for \$211,128.00, ESSER III funds will pay for \$5,450.00 and the Preschool Special Education budget will pay for the balance amount of \$22,476.00.

C. 66.03.01 Inter-District Agreements – Project Search Program Agreement – Approval

The District's Project Search program has attracted two students from the Port Edwards School District. Non-resident students are allowed into the program provided the two Districts enter into a cooperative 66.03.01 agreement.

The Administration recommends entering into a 66.03.01 cooperative agreement with the Port Edwards School District for the students attending the Project Search program.
