A. Food Service 2017-18 Meal Price – Approval

BS-1 A motion was made by Larry Davis, and seconded by Katherine Bielski-Medina, that the meal price exemption from DPI be accepted and the proposal to maintain the current meal prices for the 2017-18 school year be recommended for approval to the Board of Education. The motion was carried.

- B. Wireless Access Points Purchase District Technology Approval
 - BS-2 A motion was made by Katherine Bielski-Medina, and seconded by Larry Davis, that the proposal for the purchase of 85 Meraki MR42 wireless access points from PDS at a cost of \$44,740.60, with 40% of the cost being funded from the District Technology Referendum budget, and 60% being funded from Federal E-Rate dollars be recommended for approval to the Board of Education. The motion was carried.
- C. Firewall Purchase District Technology Approval
 - BS-3 A motion was made by Larry Davis, and seconded by Katherine Bielski-Medina, that the proposal for the purchase of 2 Fortinet 600D Firewalls from PDS at a cost of \$32,877.78, with 40% of the cost being funded by the District Technology Referendum budget, and 60% being funded by Federal E-Rate dollars, be recommended for approval to the Board of Education. The motion was carried.
- D. Equipment Purchase Lincoln High School Food Service Approval
 - BS-4 A motion was made by Katherine Bielski-Medina, and seconded by Larry Davis, that the proposal for the purchase and installation of Food Service equipment from Streich Equipment at a cost of \$279,718.00, with \$9,681 of the cost being funded from the General Fund Budget, and \$270,037 being funded from the Food Service Fund, be recommended for approval to the Board of Education. The motion was carried.
