 - A. Oasys LLC – Special Education Administrative Software – Approval

A motion was made by Troy Bier, and seconded by Katherine Bielski-Medina, that the **BS-1** proposed purchase of Oasys Special Education Administrative Software at a first year price of \$20,500, followed by an annual cost of \$14,500 for the second and third years, to be funded from the 2020-21 Special Education budget be recommended for approval to the Board of Education. The motion was carried.

B. Discovery Education - Approval

> A motion was made by Katherine Bielski-Medina, and seconded by Troy Bier, that the **BS-2** proposed purchase of Discovery Education Online from Capstone, at a cost of \$23,950.00, to be funded from the 2019-20 District Common School Fund budget be recommended for approval to the Board of Education. The motion was carried.

C. PebbleGo Renewal and Upgrade - Approval

> A motion was made by Troy Bier, and seconded by Katherine Bielski-Medina that the BS-3 proposed purchase of PebbleGo and PebbleGo Next from Capstone, at a cost of \$12,593.70, to be funded from the 2019-20 District Common School Fund budget be recommended for approval to the Board of Education. The motion was carried.

D. WiLs Renewals - Approval

> A motion was made by Troy Bier, and seconded by Katherine Bielski-Medina that the **BS-4** proposed renewal of various online databases and resources from WiLS, at a cost of \$13,916.73, to be funded from the 2019-20 District Common School Fund budget be recommended for approval to the Board of Education. The motion was carried.

E. Chromebook Cases Purchase - Approval

> A motion was made by Katherine Bielski-Medina, and seconded by Troy Bier, that the BS-5 proposed purchase of 350 Bump Armor CB Slim Hard Shell cases, at a cost of \$6,891.50, to be

funded from the 2020-21 District Technology budget be recommended for approval to the Board of Education. The motion was carried.

B. Chromebook Purchase – Update

Ordering prior to March 6, 2020 saves the District over \$600.00. The Chromebook purchase will be funded from the 2019-20 District Common School Fund budget.
