- A. WRAMS Auditorium Rigging and Curtain Replacement
  - BS-1 Motion by Julie Timm, seconded by Katherine Bielski-Medina, to approve the contract with Mainstage to install replacement curtains, rigging equipment and associated hardware at a cost of \$39,528.00 to be funded from the 2022-2023 Buildings and Ground Budget. Motion carried unanimously.
- B. 66.03.01 Inter-District Agreements Early Childhood Program Agreement
