A. Co-Curricular Clubs & Activities

Attachment A sets out a list of co-curricular clubs and activities that students in Wisconsin Rapids Public Schools (WRPS) are invited to participate in. B. Professional Development Highlights: 2017-18

WRPS staff had a variety of opportunities to participate in professional development opportunities during the 2017-18 school year. All opportunities were designed to meet the goals of the 2017-18 Professional Development and Strategic Plans. Kathi Stebbins-Hintz, Director of Curriculum and Instruction, will be present to share highlights of the 2017-18 school year.

C. Department of Justice (DOJ) School Safety Grant Training Requirements

During the 2018-19 school year, all WRPS staff will participate in a minimum of three hours of training in Trauma Sensitive Schools and Adverse Childhood Experiences (ACEs). This training is required since the District is a recipient of phase I of the Department of Justice's (DOJ) School Safety Grant. Attachment B sets out the opportunities for staff to receive this training.

If the District receives phase II of the DOJ's school safety grant, additional training will be required including Wisconsin DOJ Threat Assessment Team training for the District's School Safety intervention Team (SSIT), as well as sending 10 percent of our full time teachers and counselors to a DOJ-approved 12-hour Adolescent Mental Health Training program. The District is currently working with the Office of School Safety to make WRPS a training site for both of these requirements.
