A. Early College Credit Program (ECCP) and Start College Now (SCN)

There are no Early College Credit Program (ECCP) requests.

The Start College Now (SCN) Program allows high school students the opportunity to take one or more courses at any Wisconsin technical college. There are 25 students applying to take 16 different courses through the SCN program at Mid-State Technical College (MSTC) for spring 2022. The chart below sets out the information about these requests.

Roxanne Filtz, Director of Curriculum and Instruction, will present the SCN requests.

The administration recommends approval of the 25 applications to participate in the 16 requested courses at Mid-State Technical College through the Start College Now (SCN) program in the spring of the 2021-2022 school year.

#### B. New Course Proposals

At the October 2021 Educational Services Committee meeting, five new course proposals were presented to the Committee to be considered and voted on in November. A summary of each proposal was shared, with time for questions and discussion. Each course proposal can be found in the October Educational Services Committee Background in Attachments A through E.

In addition, each proposal was presented to and discussed by the Council for Instructional Improvement (CII). The Council then voted on each proposal. A summary of the CII's individual comments and vote is included in Attachment A. The central office administrative team also discussed each proposal.

Ms. Filtz will be present to answer any questions about the new course proposals.

## Based on these discussions and input gathered, the administration makes the following recommendations:

#### a. Applied Math in the Trades

This course will provide students intending to pursue a degree in the trades with another option to earn mathematics credit during their junior or senior year. This course is designed for students to learn applications of fundamental math topics used in the trades and the programs connected to the already dual-credit MSTC offerings at Lincoln High School (LHS). The goal of this course is to build experiences that can help students develop skills necessary to be more successful in the current CTE offerings by addressing skills that are within the mathematics content, but are specifically applied to the trades. This course is meant to help students that are more hand-on learners by nature, to make the connection between what they learned in earlier math courses and applications in the technical trades.

The CII supported this proposal by a vote of 26 yes, 0 no and 2 unsure.

The administration recommends approval of the course Applied Math in the Trades for a .5 mathematics credit at Lincoln High School for grades 11 and 12 to begin with the 2022-2023 school year.

#### b. Bloodstone Layout Editor Course Credit

Bloodstone is a student created and teacher guided literary project. It is a collaborative effort between LHS's Art and English/Language Arts Departments since 1977. Both departments have worked hard to keep this tradition alive under new and challenging schedule changes. The current course schedule has

not been conducive for the proper time allotments required for producing a large scale magazine in a timely manner.

Layout editors taking this course would be chosen by the instructor. Students would sign up for .5 credits during the second or third trimesters to work on layout and design work. Students would be placed in preexisting courses running in the department so this will not add any FTEs. Like yearbook, students will have the option to take the course credit more than once. The first year students will learn how to prepare artwork in Photoshop and how to use Adobe InDesign to layout the magazine. During their second and/or third year, they will be applying the skills from the first year to complete the magazine layout and design the table of contents.

We foresee two to three students each year utilizing the credit option.

The CII supported this proposal by a vote of 28 yes, 0 no and 0 unsure.

The administration recommends approval of the course Bloodstone Layout Editor for a .5 Elective credit at Lincoln High Shool for grades 10–12 to begin with the 2022-2023 school year.

#### c. Modern World History

Modern World History is a one term elective course covering the chronological period 1200-1990. The course is open to juniors and seniors. The course approaches the study of world history through a global perspective, meaning each of the world regions receives roughly equal attention. By taking World History, students will become more engaged in the global community through the study of diverse viewpoints and global affairs.

Modern World History is available as a transcripted credit, meaning students have the option to earn college credit for the course through UW Stevens Point. Students who do not wish to take the course as a transcripted credit can still enroll in the course and earn .5 credits in social studies.

The CII supported this proposal by a vote of 28 yes, 0 no and 0 unsure.

The administration recommends approval of the course Modern World History for a .5 social studies credit at Lincoln High School for grades 11 and 12 to begin with the 2022-2023 school year.

#### d. Criminal Justice

Criminal Justice provides an overview of the complex system making up the criminal justice system. The course will explore the process taken from the time a crime takes place through the trial process. Students will study complex topics, such as the balance between individual rights and apprehending a criminal, and participate in several highly engaging activities, including a simulated crime scene investigation and a mock trial. Additionally, students will reinforce skills learned in their language arts courses when they write legal briefs and opening

and closing statements, and build on skills learned in social studies such as questioning, argument analysis, and source evaluation. Finally, students will hear from professionals in the field and will have the opportunity to use their knowledge to compete on the LHS Mock Trial team in state competitions.

To fulfill their junior year graduation requirement, students have the option to take U.S. Government, AP Government, or The Law. Students can take only one of the courses because similar content is covered in each course. Consequently, students interested in either Government or The Law do not have options to advance their knowledge by taking an elective course. Foundations in Criminal Justice will allow students who have a special interest in government to further their understanding by digging deeper into the primary components of the criminal justice system - a topic that is not covered in any of our current offerings.

The CII supported this proposal by a vote of 28 yes, 0 no and 0 unsure.

The administration recommends approval of the course Criminal Justice for a .5 social studies credit at Lincoln High School for grades 11 and 12 to begin with the 2022-2023 school year.

#### e. Environmental Lit. in the Outdoors

In an effort to provide an in-depth experience of Environmental Literature and Outdoor Education for students who take both classes, we are proposing a combination of both classes, into a 1 credit course. Any student could take this course during their senior year as a .5 credit towards their Physical education requirement and .5 credit towards their English requirement.

The benefits of taking this course:

- 1. Continued development of social emotional skills help recognize contribution of group members' skills, considering a variety of factors when making decisions, evaluate behavior norms in a variety of outdoor activities
- 2. Cross curricular approach to English and Physical Education in conjunction with learning to analyze text, acquiring appropriate nomenclature, students will be able to draw on personal experiences in related outdoor activities to support their analysis of texts.
- 3. Advocacy for Outdoors Students will gain knowledge of current environmental issues and the impact of activities in the outdoors. Students will be able to use this knowledge to analyze and draw conclusions from texts and personal experiences.

The CII supported this proposal by a vote of 24 yes, 3 no and 1 unsure.

The administration recommends approval of the course Environmental Lit. in the Outdoors for a .5 English credit and a .5 physical education credit at Lincoln High School for grade 11 students to begin with the 2022-2023 school year.







## Forward & DLM Exam 2020-21 % Proficient and Advanced Wisconsin and WRPS Full Academic Year (FAY)




## Percent of Students Not Tested At Each Grade Level 2020-2021




## **Percent Not Tested Trends**






## Forward & DLM Exam 2020-21 % Proficient and Advanced Wisconsin and WRPS Full Academic Year (FAY)





## Forward & DLM Exam 2020-21 % Proficient and Advanced Wisconsin and WRPS Full Academic Year (FAY)















## Forward Exam 2020-2021 Valley & Surrounding Districts Full Academic Year (FAY)


