A. K-5 Health Curriculum Maps

Roxanne Filtz, Director of Curriculum and Instruction, along with Amy Andrys, K-12 Health Education Curriculum Chairperson, will be present to share the proposed curriculum maps for the K-5 Health Curriculum. Ms. Andrys and the K-5 Health Education Subcommittee have been working to revise the K-5 Health Curriculum Maps, centering their work on the Wisconsin State Standards/Health Literacy Standards. Ms. Andrys presented the proposed K-5 curriculum maps to the District Council for Instructional Improvement (CII) on April 20, 2022. The CII unanimously voted to recommend approval of the proposed curriculum maps. Attachment A presents the proposed maps. Once the curriculum maps are approved by the Board of Education, the Health subcommittee will begin the process of cross walking the standards with the District Counseling Standards, the Physical Education Standards, as well as other general education curriculum standards. The process of piloting materials for acquisition will begin in 2022-2023 and full implementation will take place during the 2023-2024 school year.

The administration recommends adoption of the proposed K-5 Health Curriculum maps as presented in Attachment A, beginning with the 2023-2024 school year.

B. K-5 Physical Education Acquisition

At its May 9, 2022 school board meeting, the Board of Education approved the Physical Education curriculum maps as presented. Ms. Filtz will be present to share the physical education acquisition proposal for grades K-5. The Physical Education Sub-Committee discussed potential materials to support the approved curriculum

and secured several quotes from a variety of vendors. Because the acquisition is equipment, there was not a public viewing of the proposed materials. Attachment B sets out the recommendation for the Elementary Physical Education Acquisition.

The Council for Instructional Improvement (CII) discussed the acquisition proposal at its April 20, 2022 meeting and unanimously voted to recommend possible approval of the proposed purchases.

The administration recommends approval of the proposed elementary physical education acquisition outlined in Attachment B in the amount of \$104,267.07 to be funded through the WRPS Referendum Curriculum budget.

C. K-5 English Language Learners Resource Purchase

The District would like to purchase National Geographic Learning's *Reach Higher* for use in the elementary English Language Learners (ELL) program for students who qualify for services. *Reach Higher* uses a global perspective to help students learn English, learn about the world, and learn about themselves through combining science and social studies content with authentic literature.

After details of the program were presented at the April 20, 2022 CII meeting, the committee unanimously agreed to bring this program forward to the Board of Education for consideration and possible approval. A public viewing of the materials was held on May 5, 2022, from 3:30–5:30 pm. Twelve community members and six school board members attended. The one comment sheet that was left that evening for the *Reach Higher* program read, "I'm always a fan of National Geographic and the diversity it represents. The bright pictures and scenarios will help the students view a new world that they might not see every day."

The administration recommends approval of the purchase of National Geographic Learning's *Reach Higher*, both digital and print resources, for grades kindergarten through 5th grade at a total cost of \$15,412.65 to be paid through the Referendum Curriculum budget for implementation beginning with the 2022-2023 school year.

D. K-5 Special Education Reading Resource: *Reading Mastery Signature Series* Purchase

The District Curriculum and Pupil Services departments are preparing to purchase materials for use in the elementary Special Education program, and are interested in purchasing resources for students needing additional support in reading. The materials being considered for purchase are SRA's *Reading Mastery Signature Edition*. *Reading Mastery Signature Edition* uses the highly explicit, systematic approach of Direct Instruction to accelerate reading and help students achieve a high rate of success. *The Reading Mastery Signature Edition* helps students be more successful as follows:

- a. Addresses five essential components of reading including phonemic awareness, phonics and word analysis, fluency, vocabulary, and comprehension
- b. Provides spelling instruction to help students make the connection between decoding and spelling patterns
- c. Develops decoding, word recognition, and comprehension skills that transfer to other subject areas

After details of the program were presented at the April 20, 2022 CII meeting, the committee unanimously agreed to bring this program forward to the Board of Education for consideration and possible approval. A public viewing of the materials was held on May 5, 2022, from 3:30–5:30 pm. Twelve community members and six school board members attended. The one comment sheet that was left that evening for the *Reading Mastery Signature Series* read, "I enjoyed the emphasis on phonics in the workbooks. How some of the letters were smaller to show students the sounds the words are forming first. Also the use of animals and pictures always holds the attention of students well."

The administration recommends approval of the purchase of the *Reading Mastery Signature Edition* for grades kindergarten through 5th grade for a total cost of \$123,640.77 to be paid from IDEA Flow Through dollars for implementation beginning with the 2022-2023 school year.

E. K-5 Social Emotional Learning Framework Resources Purchase

The District is considering purchasing the program *Move This World* as a resource to help set the foundation children need for learning and growing. *Move This World* is designed to meet students on their level for meaningful and long-lasting social and emotional learning development while protecting and supporting classroom instruction time. Giving students the skills they need to function in society develops their ability to adapt, be flexible, solve problems, and learn how to work with different types of people. The *Move This World* curriculum promotes social and emotional learning through the use of interactive videos, movement, and creative expression to help students, educators, and families develop emotional intelligence skills for long-term wellbeing. Schools implement *Move This World* lessons seamlessly into their day with short evidence-based videos that introduce a common language and methods for expressing emotion. Developed for use at all levels pre-K through grade 12, the implementation of this program can lead to deeper self-awareness, stronger relationships, effective communication, and a culture of safety and support.

After details of the program were presented at the April 20, 2022 CII meeting, the committee unanimously agreed to bring this program forward to the Board of Education for consideration and possible approval for grades K-5. A public viewing of the materials was held on May 5, 2022, from 3:30–5:30 pm. Twelve community members and six school board members attended. The one comment sheet that was left that evening for the *Move This World* resource read, "I think the videos are very engaging for the students."

The week following the public viewing, one community member responded to the *Move This World* materials via email with several website links related to the

Collaborative for Academic, Social and Emotional Learning (CASEL) Framework and Social and Emotional Learning in general. His concern regarding the shared links was "Hope-fully this isn't what the curriculum will turn out to be." There was no comment from this community member left on the survey form specifically regarding the *Move This World* resource which was previewed.

If the district purchases for a three-year period, there will be a total savings of \$7,134.00 over the course of the three years.

The administration recommends approval of the purchase of the *Move This World* Social and Emotional Learning Framework Resource for grades K-5 for a total cost of \$73,120 for three years to be paid with a combination of funds from CCEIS, BMW Grant and the Get Kids Ahead Grant and for implementation beginning with the 2022-2023 school year.

F. Renaissance Learning Purchase Contract for 2022-2023

Wisconsin Rapids Public Schools would like to enter into an agreement with Renaissance Learning to purchase Renaissance products for the 2022-23 school year for a total cost of \$47,553.02. The products utilized by WRPS include STAR Math, STAR Reading, and Freckle Math (Attachment C).

STAR Math is used to screen students three times per year to determine student progress in mathematics. STAR Math is taken by students in grades two through high school geometry. The screening is especially useful in deciding whether or not a student needs intervention or acceleration in mathematics. In addition, student results on the STAR math assessment are used for reporting math achievement as required by the State for participation in the Achievement Gap Reduction (AGR) program. Students in other grades are screened in mathematics using different products. Students in kindergarten and grade one are screened using an assessment created by district math teachers. Students in math courses beyond geometry are screened using the Early Math Placement Tool (EMPT), which is an assessment that is designed to allow high school students to see how ready they are to pursue math courses at the post-secondary level.

STAR Reading is used to screen students three times per year in grades two through five to determine student progress. The screening is especially useful in deciding whether or not a student needs intervention or acceleration in reading. In addition, student results on the STAR Reading assessment are used for reporting reading achievement as required by the State for participation in the Achievement Gap Reduction (AGR) program. Students in other grades are screened in reading using other products. Students in kindergarten through grade two are screened using the PALs screener. Students in grades six through twelve are screened using the Reading Inventory (RI).

Freckle Math by Renaissance helps K-12 teachers differentiate instruction to reach every student at their own level. The District uses Freckle Math to provide differentiated instruction in grades 6–8. This resource allows teachers to assign targeted activities to students that help fill learning gaps from previous grades as well as support current skills and concepts.

The administration recommends approval of the contract with Renaissance Learning for the 2022-2023 school year in the amount of \$47,553.02, to be paid for with the ESSER III Formula Grant.

G. Carl Perkins Grant

The purpose of the Carl Perkins Grant is to help prepare students for high-skill, high wage, or high-demand occupations in current or emerging professions; promote the development of activities that integrate rigorous and challenging academic and career and technical instruction, linking secondary education and post-secondary education for career and technical education (CTE) students; provide technical assistance and professional development related to best practices that improve CTE programs, services, activities, and quality of CTE educators, faculty, administrators and counselors; and support partnerships between secondary schools, post-secondary institutions, local workforce investment boards, and business and industry.

The 2022-2023 Carl Perkins Grant application will focus on gaps found in our CTE Comprehensive Local Needs Assessment in five CTE pathways: Agriculture, Business and Administration, Engineering, Manufacturing, and Family and Consumer Sciences Food & Beverage. Expenditures include professional development, dual credit course expansion including software and hardware for the courses, and equipment for the District's Manufacturing and Fab Lab.

The administration recommends approval of the application for the Carl Perkins Grant for the 2022-2023 school year in the amount of \$52,587.00.

H. The Department of Workforce Development (DWD) CTE Incentive Grant

The Department of Workforce Development (DWD) CTE Incentive Grant enables WRPS and area businesses and industry to provide apprenticeship opportunities and approved industry-recognized certifications for students. Lincoln High School (LHS) had seventy-eight 2021 graduates earn industry-recognized certifications resulting in \$62,400. (Funds estimated from DWD's amount per student in 2020). These funds are allocated for the growth of Career & Technical Education programs and the expansion of opportunities for students to earn industry-based certifications.

The administration recommends approval of the Department of Workforce Development Grant Technical Incentive Grant funds for approximately \$62,400.

V. Updates

A. Playground Equipment at Woodside Elementary

Woodside staff has been working on building an even stronger inclusive community by seeking out ways to partner with community resources. They are currently focusing on developing their grounds into an inclusive outdoor play, learning, and activity center to provide even more opportunities to grow their social, emotional, and academic skills and opportunities for all their students and our community.

They are in the process of applying for grants from the Legacy Foundation and Noon Hour Rotarians, as well as partnering with local businesses to donate their time and services and their products at cost. Please see Attachment D. Julie Kolarik, Principal of Woodside Elementary, will share more details and answer any questions.

B. Changes to the Approach at Wisconsin Rapids Area Middle School for Next School Year

At the May 9, 2022 School Board meeting, Sandy Hett asked for an update on the progress WRAMS is making on addressing the social and emotional needs of our students as well as behaviors and academic needs. In particular, Ms. Hett is curious about the make-up of Rapids Pride Time (RPT), the progress of the RESET program planning and parent engagement. Staff and administration from WRAMS will be present to share the planning that is occurring now and the goals for implementation for the 2022-2023 school year.

C. Update On the Use of Virtual Tickets at Athletic Events

At the May 9, 2022 School Board meeting, board members John Benbow and John Krings asked about the approach Lincoln High School uses in regards to virtual ticket sales for athletic events and the push from the Wisconsin Valley Conference (WVC) to move 100% in this direction. Ron Rasmussen, LHS principal, will be present to share specifics about the approach LHS takes at its events and to answer any questions the committee members may have regarding this issue.

D. Educator Effectiveness Grant and Educator Effectiveness Evaluation System Fees

In order to implement the Wisconsin Educator Effectiveness System, Wisconsin Rapids Public Schools receive up to \$80 per educator (i.e., superintendents, principals, teachers, and other licensed educator roles) to cover the costs associated with system development, training, software, support, resources, and ongoing refinement.

On May 11, 2022, the District received notification of the approval of the Educator Effectiveness Grant for the district in the amount of \$32,080 for the period of July 1, 2021 through June 30, 2022. The District also received an invoice from the DPI, dated May 9, 2022, for \$32,080 to cover the Educator Effectiveness Evaluation Systems fees. We will pay the invoice using the specified EE Grant funding.

E. Student Travel

a. Orchestra Trip

Ginger Marten, LHS Orchestra Teacher, is planning to take students to Minneapolis, MN on July 6, 2022, for the purpose of attending the musical, *Ain't Too Proud*. Students who are enrolled in orchestra for at least one term during the 22-23 school year are eligible to attend. Parents and guardians, as well as students graduating on May 28, 2022, are also welcome to attend with a completed volunteer application/background check. The group will depart from the LHS parking lot at noon on July 6, 2022. They will visit Mall of America first and then

attend the 7:30 pm show at the Orpheum Theatre in downtown Minneapolis. The group plans to arrive back in Wisconsin Rapids around 1:30 a.m. on July 7, 2022. The cost is \$90.00 per traveler. Fundraising profits can be applied to this trip or saved for a future trip.

b. Lincoln High School Foreign Country Trip for Summer 2024

Jeanine Kleman, Art Instructor at LHS, is in the beginning phases of planning a 13-day trip to Berlin, Prague and the Alps through Educational Tours, EF. This travel will occur during the summer of 2024. The tour will be geared toward the arts, but any LHS student can attend. A future update will be provided to the committee as to the number of students attending, chaperones and costs once the date of travel is closer and more details are finalized. At this time the cost is \$4,740.00 per student and \$5,390.00 per adult. This includes travel insurance. Once Ms. Kleman determines interest, she will ask families about fundraising ideas.
