G. Employee Wage and Benefit Compensation Considerations

PS – 13 Motion by Anne Lee, seconded by Mary Rayome to recommend approval of a 2016-17 wage increase of 0.12% for school psychologists retroactive to the beginning of the 2016-17 school year, and a 2017-18 wage increase of 1.26% effective July 1, 2017.

Motion carried unanimously.

Dr. Christianson recommended the Committee consider a potential adjustment be made to the health retirement benefit section of the Benefit Document for school psychologists. Dr. Christianson explained that a grandfather clause in the health retirement benefit section of the Benefit Document, which was established in 2007, was no longer needed since none of the current school psychologists meet the language criteria, which was applicable to former employees who have since retired.

Dr. Christianson introduced an alternative language option which would instead define the current health retirement benefit level. Alternatively, a second option proposed would replace current language altogether with new language to provide school psychologists the same health retirement benefit which is currently provided to teachers. If the health retirement benefit were to change for the teacher group in the future, the health retirement benefit would also change for school psychologists to match the teacher benefit.

Following discussion, the Committee elected to table the language change to provide additional time to consider the options. Further consideration and possible action may occur at a future Committee meeting.

PS – 14 Motion by Mary Rayome, seconded by Anne Lee to recommend approval of a 2016-17 wage increase of 0.12% for school nurses retroactive to the beginning of the 2016-17 school year, and a 2017-18 wage increase of 1.26% effective July 1, 2017.

Motion carried unanimously.

PS – 15 Motion by Anne Lee, seconded by Mary Rayome to recommend approval of a benefit adjustment for school nurses to take effect on September 1, 2017, which provides 100% Board payment of the premium for single or family dental insurance; and 100% Board payment of the premium for term life insurance coverage equal to the earnings of the individual employee's previous year's salary, rounded to the next higher thousand.

PS – 16 Motion by Mary Rayome, seconded by Anne Lee to recommend approval of a 2016-17 wage increase of 0.12% for computer technicians retroactive to July 1, 2016, and a 2017-18 wage increase of 1.26% effective July 1, 2017.

PS – 17 Motion by Anne Lee, seconded by Mary Rayome to recommend approval of a benefit adjustment for computer technicians to take effect on September 1, 2017, which provides 100% Board payment of the premium for single or family dental insurance.

PS – 18 Motion by Mary Rayome, seconded by Anne Lee to recommend approval of a 2016-17 wage increase of 0.12% for the PAC director retroactive to July 1, 2016, and a 2017-18 wage increase of 1.26% effective July 1, 2017.
