D. 2021-2022 Open Enrollment Data Review and Application Approvals

Brian Oswald, Director of Human Resources, shared the current number of open enrollment transfer in and transfer out applications for the WRPS District. As of May 3, 2021, WRPS has 150 transfer in applications and 78 transfer out applications.

E. Dental Insurance Renewal Rate

Brian Oswald, Director of Human Resources, shared with the Committee the need for the District to increase dental premiums by 3.22 percent effective July 1, 2021. Single plans will go from \$40.00 to \$41.00 a month and family plans will go from \$120.00 to \$124.00 a month. The dental plan will also include three improvements: preventative services do not apply to the annual maximum, reduced x-rays, and resin composite fillings.
