D. Summer Swim Site Coordinator

Brian Oswall, Director of Human Resources, shared with the Committee how the role of the Head Guard has expanded during summer swim lessons. Administration recommended a title change to Assistant Summer Swim Coordinator and pay rate increase to \$17.00/hour. This title and pay increase is effective June 14, 2021 and is only for summer swim lessons.

Elizabeth Messerli, Director of Food Services, explained the need to add a delivery driver and breakfast server. The delivery driver is needed due to Central Oaks moving to EJH along with increased demand across the District. The breakfast server is needed due to 4k and Early Childhood being held at Pitsch Early Learning Center.

Ms. Messerli also explained the need to change the job responsibilities and pay of one of the Second Cooks at LHS and one of the Kitchen Helpers at WRAMS. One of the Second Cooks at LHS will now be the First Cook. The Kitchen Helper at WRAMS will now be an A La Carte Cook.

F. Athletic Director Secretary Position

Brian Oswall, Director of Human Resources, and Craig Broeren, Superintendent, share with the Committee the need for a District employee to help facilitate the use of the quadplex. Administration recommended a title change of the Athletic Director Secretary to Administrative Assistant to the Lincoln High School Athletic Director/LHS Athletic Facilities Coordinator. This job would now have an 8 hour, 260-day work schedule and a pay rate increase of \$17.80 per hour after the probationary period. This job would provide a consistent contact person with knowledge of the District's athletic facilities.
