II. Public Comment

Bill Winch addressed the committee stating he obtained alternate pricing for the cost of repairs to the Vesper Community Academy facility as follows: 1) \$3,000.00 to extend the life of the roof 3 additional years; and 2) \$3,600.00 to replace blocked drain tile that is preventing water from properly draining away from the building. Lastly, the projected cost of \$400,000.00 to install univents for heating was stated to be unnecessary for operation of the facility. The Committee directed Ed Allison, Building and Grounds Director, to provide information to the Board covering the concerns expressed by Mr. Winch.
