 - A. Food Service 2018-19 Meal Price – Approval

A motion was made by Larry Davis, and seconded by Katherine Bielski-Medina, that the **BS-1** proposal to increase the following school lunch prices: \$2.05 for grades K-5; \$2.25 for grades 6-8; \$2.45 for grades 9-12; and \$3.25 for adults, to remain in compliance with federal regulations, be recommended for approval to the Board of Education. The motion was carried.

Β. Computer Purchase - Grant, Washington, and Woodside Elementary Schools - Approval

BS-2 A motion was made by Katherine Bielski-Medina, and seconded by Larry Davis, that the proposal to purchase ninety-two HP ProDesk computers from PDS at a total cost of \$49,864.00, with funding from the District Technology budget, be recommended for approval to the Board of Education. The motion was carried.

C. Gymnasium and Athletic Field Score Boards - Wisconsin Rapids Area Middle School - Approval
