- A. Canvas Learning Management System Purchase Approval
 - BS-1 A motion was made by Larry Davis, and seconded by Katherine Bielski-Medina, that the proposal to purchase a 3-year license of the Canvas Learning Management System from Instructure at a total cost of \$46,780, to be paid in three annual installments as described in the contract, with funding from the District Technology and Curriculum budgets, be recommended for approval to the Board of Education. The motion was carried.
- B. Chromebook Cases Purchase Approval
 - BS-2 A motion was made by Katherine Bielski-Medina, and seconded by Larry Davis, that the proposal to purchase 1500 Bump Armor CB Slim Hard Shell cases, at a cost of \$28,314.31, to be funded from the 2019-20 District Technology budget and District Technology referendum budget, be recommended for approval to the Board of Education.
