 - A. **CESA 5 Contract - Approval**

BS-1 Motion was made by Julie Timm, seconded by Christopher Inda, to approve the proposed CESA 5 agreement for the 2025-26 school year, which amounts to \$394,836.80 and will be paid for with Flow-Through and other District accounts. Motion carried unanimously.

B. Automated External Defibrillator (AED) Units - Approval

> BS-2 Motion was made by Christopher Inda, seconded by Julie Timm, to approve LifeGuard MD, Inc.'s proposal for 26 AED Units, which will cost \$46,712.00 and be paid from the 2024-25 Community Service Budget. Motion carried unanimously.

C. Four-Year-Old Kindergarten (4K) Program Agreement Increase - Approval

- C. Bus Contract Fuel Update

Safe-Way currently purchases its bus fuel from Levenhagen Oil Corporation in Neenah, Wisconsin. Safe-Way obtained quotes from Levenhagen Oil and Insite FS in Wisconsin Rapids. The Insite FS quote cost for the Kellner location was 3.2 cents less per gallon, and the Rudolph location was 44.9 cents less per gallon compared to Levenhagen. Safeway feels very comfortable with the utilization of Insite FS, and we anticipate a transition will take place in early March. Per the transportation contract, the district is responsible for the cost of the fuel.
