A. Securly Purchase – Web Content Filtering and Management – Approval

Phil Bickelhaupt, Directory of Technology, will be present to explain as needed the Securly software and filtering options.

As the District continues its transition to a 1:1 learning environment at Lincoln High School and Wisconsin Rapids Area Middle School, and the increased use of Chromebooks at the elementary schools, the District is exploring options for increased web filtering and reporting of District laptop use both at school and at home. Final costs and a recommendation to purchase will be presented at the time of the meeting.

The Administration recommends that, the proposal to purchase 44 months of Securly Anywhere Filtering from Securly, at a cost of \$41,962.80, to be paid in three annual installments of \$13,987.60, with funding from the District Technology budget, be recommended for approval to the Board of Education.
