A Google survey was sent out to students at the end of the school year, and results from that survey were shared with the Committee. It was also noted that the professional development provided by the administration and Educator Effectiveness coach Melanie Kozlowski, was very instrumental in a successful first year with the trimester schedule.

Kathi Stebbins-Hintz, Director of Curriculum and Instruction, reviewed steps the ACP Committee has taken to establish their vision for ACP, and set goals for the 2016-17 school year.
