I. Call to Order

Anne Lee called the meeting to order at 7:03 a.m.

II. Public Comment

There was no public comment.

- III. Actionable Items
  - A. Renaissance Learning Products

Jennifer Wilhorn, Elementary Literacy Supervisor and Principal at Vesper Community Academy, reviewed contracts that Wisconsin Rapids Public Schools (WRPS) has with Renaissance Learning for STAR Math and STAR Reading. These screening tools are used three times per year. The District will no longer purchase Accelerated Math Fluency. Ms. Stebbins-Hintz, Director of Curriculum and Instruction is still negotiating contracts for Accelerated Reader and Accelerated Math. Sandra Hett questioned the discount offered as well as whether we are piloting materials for them.

ES-1 Motion by Katie Bielski-Medina, second by Mary Rayome, to approve the contract with Renaissance Learning for purchase of STAR Math and STAR Reading for the 2017-18 school year in the amount of \$28,178.56, to be paid for from referendum funds.

## Motion carried on a vote of 4 to 1. Sandra Hett voted no.

B. City Pond Partnership

Mrs. Wilhorn explained that the City of Wisconsin Rapids issued the contract set out in Attachment B for WRPS students to use the city pond behind Lincoln High School. Dave Bergerson, WRPS Science Coordinator and Lincoln High School Science Teacher had reviewed the partnership project at the July Educational Services Committee meeting. Mrs. Hett questioned who is responsible in the event of property damage. Mr. Broeren indicated he had a conversation with Mayor Vruwink and although not reflected in the contract, he felt the City and District would work together to resolve any concerns. Structures placed by WRPS would be the District's responsibility.

## ES-2 Motion by Mary Rayome, second by John Krings, to approve the contract set out in Attachment B between WRPS and the City of Wisconsin Rapids, allowing the District to utilize the pond and property surrounding it.

## Motion carried unanimously.
