I. Call to Order

Maurine Hodgson, Administrative Assistant to the Superintendent and Secretary to the Board of Education, was present to review recommended changes to Board Policies as a result of statutory changes which eliminated the Course Options and Youth Options Programs, and subsequently launched the Early College Credit Program (ECCP) and Start College Now (SCN) Program. Ms. Hodgson shared a comparison chart that outlined changes between the programs. She also shared revised application forms and documentation that counselors utilize with students interested in these programs. Ms. Hodgson was recognized for the many hours she spent researching and revising these policies.

- IV. Updates
 - A. New Course and Curriculum Modification Proposals

Kathi Stebbins-Hintz, Director of Curriculum and Instruction, reviewed course and curriculum modification proposals requested for implementation in the 2018-19 school year. She explained that these proposals will be reviewed by relevant CII Sub-Committees, building leadership committees, and the District CII Committee. Results will be shared at the November Educational Services Committee and the Committee will vote on these proposals at that time.

B. Wisconsin Student Assessment System (WSAS) Results (Part I)

Ms. Stebbins-Hintz shared a detailed analysis of the assessment results for the 2017-18 school year. Information from the Forward Exam, ACT Aspire, and the ACT were shared and discussed.

C. Every Student Succeeds Act (ESSA) Update

Ms. Stebbins-Hintz reviewed grant requirements for Titles I, II, III and IV. Funds for Title I, II and III were reduced for this year; however, Title IV had an increase that helped compensate for the loss of funds in the other Title programs. Parochial and private schools receive a percentage of the funds. Ms. Stebbins-Hintz also shared a PowerPoint outlining allocations and how the District plans to use these dollars.

D. Legislative Agenda

Craig Broeren, Superintendent, opened a discussion about how to proactively engage our legislature via our local representatives. He suggested actively engaging them as the bi-annual budget is on the legislative agenda. He also stated we should contact not only our local representatives, but representatives involved on specific committees related to WRPS concerns.
