Ms. Stebbins-Hintz reviewed recommendations for new courses or modifications to curricula. These recommendations will be reviewed and voted on by the District CII Committee, and their recommendations brought back to the Educational Services Committee for approval in November.

There was discussion on the schedule change proposal for WRAMS. Ms. Stebbins-Hintz stated that Central Office Administrators (COA) also had an extended discussion regarding this. It was felt this proposal should be tabled for next school year, allowing more time for discussion and consideration of alternatives.

B. Wisconsin Student Assessment System (WSAS) Results: 2018-19

A hand-out on the 2018-19 WSAS results was shared with the Committee. Ms. Stebbins-Hintz reviewed results of the Forward, ACT Aspire, and ACT Statewide exams. Test scores by district, building, and grade level were shared, as well as achievement gap data and comparisons with other districts.
