A. Pupil Academic Standards

Craig Broeren, Superintendent, presented Pupil Academic Standards on which the WRPS curriculum is based, and which will be in place for the 2019-20 school year. Wisconsin Standards for Theatre Education, Wisconsin Standards for Dance, and Wisconsin Standards for World Languages were promulgated by the Wisconsin Department of Public Instruction (DPI) during the 2018-19 school year. The CII sub-committees for English/Language Arts, Physical Education, and World Languages will be using these new standards to develop future curriculum changes and modifications for their respective content areas. As required in State Statutes, notice of this information will be provided to parents through the WRPS website.
