D. 2019-2020 Open Enrollment Data Review and Application Approvals

Currently under open enrollment there are 154 students attending WRPS from other school districts and 278 students who have transferred to other school districts. The District also has an additional 113 nonresident students attending WRPS under a 66.030 agreement. The following is a history of *initial open enrollment applications* that have been received.
