A. Proposal for a New Position in the Food Services Department

The Committee was provided an update from Dr. Christianson and Ms. Severson, Director of Food Services, on a proposal to establish a new, non-classified "food production coordinator" position in the Food Services Department. The food production coordinator would assist the Director of Food Services with the administration of the District's food services program in accordance with local, state, and federal requirements and help ensure the nutritional and financial integrity of the District's food services program.

B. Substitute Clerical and Support Staff Aide Compensation

The Committee discussed the District's current substitute clerical and support staff aide pay rate. Dr. Christianson recommended the Committee consider an hourly wage rate increase for substitute clerical and support staff aides to take effect later during the 2017-18 school year. Additional substitute clerical and support staff aide pay rate information will be brought forward to the Committee for further discussion and possible action at a future meeting.

C. Summer School Teacher Compensation

The Committee discussed summer school teacher pay rates. Dr. Christianson recommended the Committee consider a potential pay increase for District summer school teachers to take effect beginning with the start of the 2018 summer school session. Additional summer school teacher pay rate information will be brought forward to the Committee for further discussion and possible action at a future meeting.
