Motion by John Benbow, seconded by Troy Bier to move into closed session pursuant to Wis. Stats. §19.85(1)(c) for the purpose of reviewing individual administrator job performance evaluation information and to perform the Board’s annual evaluation of the Superintendent’s job performance; and to consider individual administrator contract renewals/extensions and administrator compensation and benefit information. Motion carried unanimously on a roll call vote.
