President John Krings called the meeting to order at 5:52 p.m.

Roll Call

Motion by Sandra Hett, seconded by Larry Davis to move into closed session pursuant to Wis. Stats. §19.85(1)(c) for the purpose of considering a recommendation for the appointment of an individual to the position of Associate Principal at Lincoln High School, and an individual to the position of Principal at Mead Elementary Charter School including individual contract, wage, and benefit information for the individuals being recommended; and to also consider any recommended professional staff preliminary notices of non-renewal. Motion carried unanimously on a roll call vote.

Motion by John Benbow, seconded by Larry Davis to move into open session at 6:34 p.m. Motion carried unanimously.

Motion by John Benbow, seconded by Larry Davis to approve of the appointment of Nicholas Sydorowicz to the position of Associate Principal at Lincoln High School with a two-year, 220 day contract effective July 1, 2018 through June 30, 2020 at an annual salary rate of \$94,548.00 in year one, and \$96,538.00 in year two, with administrator benefits, and pending release of any current contract. Motion carried unanimously on a roll call vote.

Motion by Mary Rayome, seconded by Sandra Hett to approve of the appointment of Penny Antell to the position of Principal at Mead Elementary Charter School with a two-year, 210 day contract effective July 1, 2018 through June 30, 2020 at an annual salary rate of \$91,949.00 in year one, and \$93,884.00 in year two, with administrator benefits, and pending release of any current contract. Motion carried unanimously on a roll call vote.

Motion by John Benbow, seconded by Katie Medina to authorize the administration to provide notice of preliminary non-renewal to an individual as discussed in closed session. Motion carried unanimously.
