



## Summer 2026 - Free Meals for All Kids!



Stressing the importance of offering nutritious meals to children during the summer months, the School District of Wisconsin Rapids announces the sponsorship of the *Summer Food Service Program*.

The Summer Food Service Program provides nutritious meals for children during the summer when free and reduced-price school meals are typically unavailable. **Free meals will be made available to all children 18 years of age and under.** Persons over 18 years of age who are determined by a state or local public educational agency to be mentally or physically disabled and who also participate in a public or private non-profit school program during the regular school year may receive free meals as well.

The following locations will be serving free meals this summer. Participants **must be present** to receive a meal, but do not need to consume the meal on site. **Please note that no meals will be available on Friday, July 3<sup>rd</sup>.**
