Our current auditing firm, Hawkins Ash CPA, LLP, is proposing a service agreement for the 2014-15, 2015-16 and 2016-17 school years. The proposal represents a $1\frac{1}{2}$ % increase for the first year of the agreement and a 3% increase for each of the last two years of the agreement. The Business office has worked with the firm of Hawkins Ash CPA, LLP since 2009 and found them to be reasonable and professional.

The administration recommends that the three year proposal from Hawkins Ash CPA, LLP to provide audit services for the 2014-15, 2015-16 and 2016-17 school years at a cost of \$18,475.00; \$19,025.00; and \$19,575.00 respectively be recommended for approval to the Board of Education.
